- At the bottom of the page, it is important that the student indicate any program or sport they plan to participate in.

**CCSD Parking Permit Application and Vehicle Registration form**

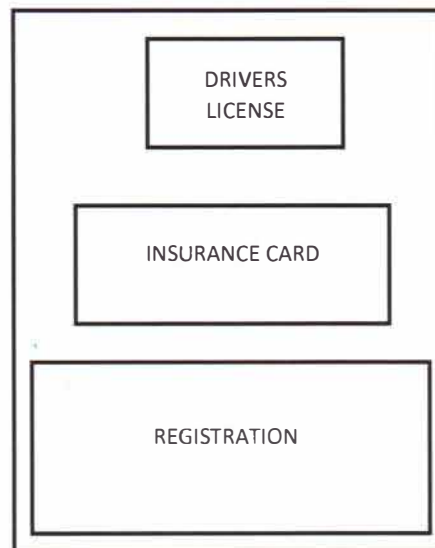
- Fillable form that student and parent/guardian will need to complete
- Once printed out, student and parent/guardian must sign document

**CCSD Parking Rules and Regulations**

- Student and parent/guardian **MUST** read
- **PLEASE be sure to read line 8 – Proof of insurance must have student’s name on policy as required by State Law.**

Please print out documents. Return RRHS parking information (initialed) & CCSD Parking Permit Application and Vehicle Registration (signed by student and parent/guardian), along with supporting documentation and fees to the athletic office. **NO COPIES OF SUPPORTING DOCUMENTATION WILL BE MADE AT THE SCHOOL! YOU MUST BRING WITH YOU.**

By initialing the below statements, you are agreeing that you understand these policies.

**Student and Parent Must Initial**

\_\_\_\_\_ 1. If another vehicle is driven other than the one on file, you must come to the Athletic Office 2302 for a temporary Tag. Failure to do so may result in a citation and fine.

\_\_\_\_\_ 2. If a new vehicle is purchased, you must bring a copy of the new insurance coverage and bill of sale or registration to the Athletic Office 2302 within the first 3 days of purchase. Failure to do so may result in a citation and fine.

\_\_\_\_\_ 3. Space sharing/lending is not allowed, doing so may result in a citation and fine or suspension/revoking of permit and all monies lost.

\_\_\_\_\_ 4. Giving or Selling your pass to someone, even temporarily will result in the permit being revoked and all monies lost.

\_\_\_\_\_ 5. Leaving campus during the school day without properly checking out, whether in your car, someone else's car or walking will result in your permit being suspended or revoked.

\_\_\_\_\_ 6. I understand that I may not go to my car during the day without a pass from Administration.

\_\_\_\_\_ 7. Per Georgia Law O.C.G.A. 40-6-241.1, CCSD has a strict cell phone policy. Texting or Talking on a cell phone while driving may result in a citation and fine and parking being suspended/revoked, and all monies forfeited. By initialing you agree that you have read and understand this policy.

\_\_\_\_\_ 8. I have read and understand the County Parking Rules and Regulations as stated on the back of the parking application.

\_\_\_\_\_ 9. As stated under line 6 on parking application, we will be enforcing the Suspension of Parking Permits for 8 or more unexcused absences and 6 or more unexcused tardies.
