**RESOLUTION OF THE BOARD OF EDUCATION OF CHEROKEE COUNTY**

WHEREAS, members of the Cherokee County Legislative Delegation sponsored HB306 (2017); and

WHEREAS, HB306 was subsequently approved by the 2017 Georgia General Assembly and was signed by Governor Nathan Deal on May 2, 2017

NOW, THEREFORE, be it resolved and approved by a vote of \_\_\_ votes in favor and \_\_\_ votes against by the members of the Cherokee County Board of Education as required by HB306 at a duly called and advertised meeting held on May 18, 2017, that the serving Chair of the Board of Education will be compensated at the rate of \$1,200 per month and the other serving members of the board will be compensated at the rate of \$1,000 per month. The provisions hereof will go into effect in January 2019 and continue thereafter until further act of the Georgia General Assembly.

House Bill 306 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the membership of the Board of Education of Cherokee  
2 County, approved April 17, 1973 (Ga. L. 1973, p. 3207), as amended, so as to change  
3 provisions relating to the compensation of the members of said board of education; to  
4 provide for related matters; to provide an effective date; to repeal conflicting laws; and for  
5 other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act providing for the membership of the Board of Education of Cherokee County,  
9 approved April 17, 1973 (Ga. L. 1973, p. 3207), as amended, is amended by striking  
10 Section 4B and inserting in its place a new Section 4B to read as follows:

11 "SECTION 4B.

12 The chairman of the board of education shall be compensated in an amount to be determined  
13 by the board, but not to exceed \$1,200.00 per month. Each of the other members of the  
14 board shall be compensated in an amount to be determined by the board, but not to exceed  
15 \$1,000.00 per month. The chairman and other members shall be paid in equal monthly  
16 installments from the funds of the board of education."

17 **SECTION 2.**

18 This Act shall become effective on January 1, 2019.

19 **SECTION 3.**

20 All laws and parts of laws in conflict with this Act are repealed.
